Addendum 1: Questions from RFP 2024-0010 Town of Wake Forest Ground-Penetrating Radar and Public Archaeology Workshop January 28, 2025

Q1. Page 5 – During the archaeology and cemetery workshop, will we have access to facilities where we can show a slide show?

A1. The Town envisions two workshops (one at each cemetery) as described in the scope of work. Please provide you plans for the workshop component in your proposal. Clearly state any expectations of the Town and/or congregations.

Q2. Pages 46-47 – Would it be possible for the Town of Wake Forest to outline specific areas where the GPR survey footprints should be located within both church cemeteries?

A2. See maps attached to this addendum.

Q3. What are the vegetation conditions at the cemeteries? Could the Town of Wake Forest provide recent photographs?

A3. There is minimal vegetation.

Q4. Is this just looking for GPR and workshops, or are you also interested in having above ground markers documented and recorded?

A4. Additional above ground marker documentation and recording work is not part of this scope of work. However, if you think that is necessary for a successful project, please include it in your proposal and clearly state the benefit. Note: There is no additional funding beyond what is specified in the RFP.

Q5. The RFP defines the Friendship Chapel survey as 2.90 acres. The polygon provided in the RFP, when georeferenced, yields a calculated area of 4.43 acres. Could the Town Wake Forrest please confirm the acreage, or polygon provided (see Figure 1 attached)?

A5. The polygon provided in the RFP is the entire church parcel including the church, parking lot, and cemetery. The cemetery is approximately 2.9 acres. See map attached to this addendum.

Q6. The RFP defines the Olive Branch Baptist Church survey as 1.15 acres. The polygon provided in the RFP, when georeferenced, yields a calculated area 2.02 acres. Could the Town Wake Forrest please confirm the acreage, or polygon provided (see Figure 2 attached)?

A6. The polygon provided in the RFP is of the entire church parcel including the church, parking lot, and cemetery. The cemetery is approximately 1.15 acres. See map attached to this addendum.

Q7. Could the Town of Wake Forrest Provide the Survey areas as an ESRI Shapefile or KML?

Q8. What are the current ground conditions of each of the survey areas, can current overview photographs of each location be shared, to assist in scoping the clearing/ mowing?

A8. Both cemeteries have minimal vegetation and are maintained. We do not have any photographs available. See attached Google Streetview photos.

Q9. Does the Town of Wake Forrest have an objection to collecting data at a tighter transect interval than 50 cm?

A9. The Town of Wake Forest and NC OSA do not have an objection to collecting data at a tighter transect interval than specified in the Scope of Work. Please specify in proposal any differences from what is required and clearly state the benefit. Note: There is no additional funding beyond what is specified in the RFP.


